ITEMS THAT ARE NOT ALLOWED TO BE CARRIED IN CHECKED OR CARRY ON BAGGAGE



FLAMMABLE SUBSTANCES AS PROVISION FOR PASSENGER AND CREW		
ITEMS	CARRY-ON BAGGAGE	CHECKED BAGGAGE
<p><b>ALCOHOLIC BEVERAGE</b>                      in retail packaging containing 24% to 70% alcohol by volume, in receptacles not exceeding 5L, total net quantity per person is 5L,</p> <p><i>Note: Alcoholic beverage must be in its Original and Sealed Retail Packaging. Broken or tampered seals will not be accepted for carriage.</i></p>		

# Restricted Items

<p><b>NON-RADIOACTIVE, MEDICINAL OR TOILET ARTICLES</b> (including aerosols) such as hairsprays, perfumes, colognes and medicine containing alcohol. The total net quantities of these articles must not exceed 2L or 2Kg, and the net quantity of each single article must not exceed 0.5Kg or 0.5L</p> <p><i>Note: Containers cannot be more than 100ml. LAGS must be placed inside a sealed, transparent and resealable 1 Litre Bag. Only 1 bag per person is allowed.</i></p>	 *Subject to local airport restriction on liquid, aerosols and gels (LAGS)	
<p><b>WORK TOOLS OR EQUIPMENT</b> Small gas-powered engine (i.e. chain saw) is accepted only when trace or smell of fuel is purged / removed.</p>		
<p><b>OTHER DANGEROUS GOODS</b></p>		<p>SEE IATA DGR Table 2.3.A</p>

## SECURITY REMOVED ITEMS (SRI)

Not Allowed for Carry-on Baggage  
or in the Sterile Area of the Airport



### Firearms

Pistols, Revolvers, Ammunitions, Toy Guns  
and Replicas, Pellet Guns, Rifles, etc.



### Sharp Objects

Axes, Hatches, Ice Picks, Razor Blades, Knives  
and Scissors with blades > 6cm, Swords, Sabres, etc.



### Worker's Tools

Crowbars, Drills and Drill Bits, Saws, Blowtorches, etc.



### Blunt Instruments

Baseball and Softball Bats,  
Clubs and Batons such as billy clubs, blackjacks  
and night sticks, Martial Arts Equipments



### Explosives

Blasting Caps, Detonators and Fuses,  
Replica Explosive Devices, Grenades,  
Pyrotechnics, Fireworks, etc.



### Liquid, Aerosols and Gels > 100ml

Water, Sauce, Lotions, Oils, Perfumes,  
Sprays, Toothpaste, Shower Gels, etc.

**Note: All sports equipment and umbrellas of any type are not allowed to be handcarried and must be checked-in.**
